1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Neighbourhood and Location	The property under report is located within an established residential area of an ex-local authority nature to the Chryston district of Glasgow. Surrounding properties are of a similar age and style, with local amenities and public transportation found within short distance.

Weather	The weather was dry and overcast during the course of our inspection.

Chimney Stacks	<p>The chimney stack is of pointed brickwork construction, externally clad with roughcast. Surrounding flashing details are formed in lead.</p> <p>Visually inspected with the aid of binoculars where appropriate.</p>

Roofing including Roof Space	<p>The roof is of pitched design, clad with concrete interlocking tiles incorporating a concrete tiled ridge detail, PVC verge caps and ventilators with further lead flashing details.</p> <p>The property benefits from a canopy over the front entrance. The canopy is of lightweight timber construction with a mono-pitched roof, clad with concrete tiles.</p> <p>The roof void has been converted to form amenity space and therefore, our inspection of those areas was limited to the structural timbers exposed within the rear cupboard. It should be appreciated that vast areas of the roof remain unseen and concealed areas cannot be commented upon.</p> <p>Sloping roofs were visually inspected with the aid of binoculars where appropriate.</p> <p>Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.</p>

Rainwater Fittings	<p>The rainwater goods are of cast iron construction with modernisations formed in uPVC.</p> <p>Visually inspected with the aid of binoculars where appropriate.</p>

Garages and Permanent Outbuildings	<p>The property benefits from a single car detached garage.</p> <p>Outer walls of the garage are of pre-fabricated concrete panel construction, externally clad with roughcast. The roof detail is of shallow pitched design, clad with corrugated sheeting.</p> <p>Visually inspected.</p>

Outside Areas and Boundaries	<p>Garden grounds pertaining to the subject property are located to the front, side and rear elevations, with defined boundaries formed in timber fencing and metal railings.</p> <p>Private off-street parking is available on-site.</p> <p>Visually inspected.</p>

Ceilings	<p>The ceilings throughout the property are of plasterboard design.</p> <p>Visually inspected from floor level.</p>

Internal Walls	<p>The internal walls are of single leaf masonry construction, lined with lath and plaster, plaster onto hard and plasterboard.</p> <p>Visually inspected from floor level.</p> <p>Using a moisture meter, walls were randomly tested for dampness where considered appropriate.</p>

Floors Including Sub-Floors	<p>The flooring throughout the property is of suspended timber joist construction. Due to fitted carpets and floor coverings no detailed inspection was possible of the floor timbers and accordingly we cannot guarantee their soundness or otherwise.</p> <p>No access to the sub-floor area was possible at the time of our visit to the property due to fitted floor coverings. Within the limitations of our inspection there was no indication to suggest significant defects in this area. It will, however be appreciated that the area was not inspected and therefore no guarantees can be provided in this regard.</p> <p>Surfaces of exposed floors were visually inspected.</p> <p>Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch .</p>

Internal Joinery and Kitchen Fittings	<p>Internal doors are of timber construction.</p> <p>Skirting boards, door mouldings and the internal staircase are of timber construction.</p> <p>Kitchen fittings comprise a variation of fitted floor and wall-mounted units.</p> <p>Built-in cupboards were looked into but no stored items were moved.</p> <p>Kitchen units were visually inspected excluding appliances.</p>

Chimney Breasts and Fireplaces	<p>Original fireplaces within the property have been historically removed with chimney breasts blocked over with brickwork / plasterboard.</p> <p>Visually inspected. No testing of the flues or fittings was carried out.</p>

Internal Decorations	<p>The internal decoration is predominately painted and wallpapered, with pointed tiling within the kitchen and shower room.</p> <p>Visually inspected.</p>

No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p>

Gas	<p>Mains supply connected.</p> <p>The gas meter is located within an external meter box secured to the front elevation.</p> <p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p>

Water, Plumbing and Bathroom Fittings	<p>Mains supply connected.</p> <p>Where visible, the plumbing lines within the property are run in PVC and copper.</p> <p>The bathroom comprises a thermostatic mixer shower over tray, wash hand basin and WC.</p> <p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.</p> <p>It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.</p>

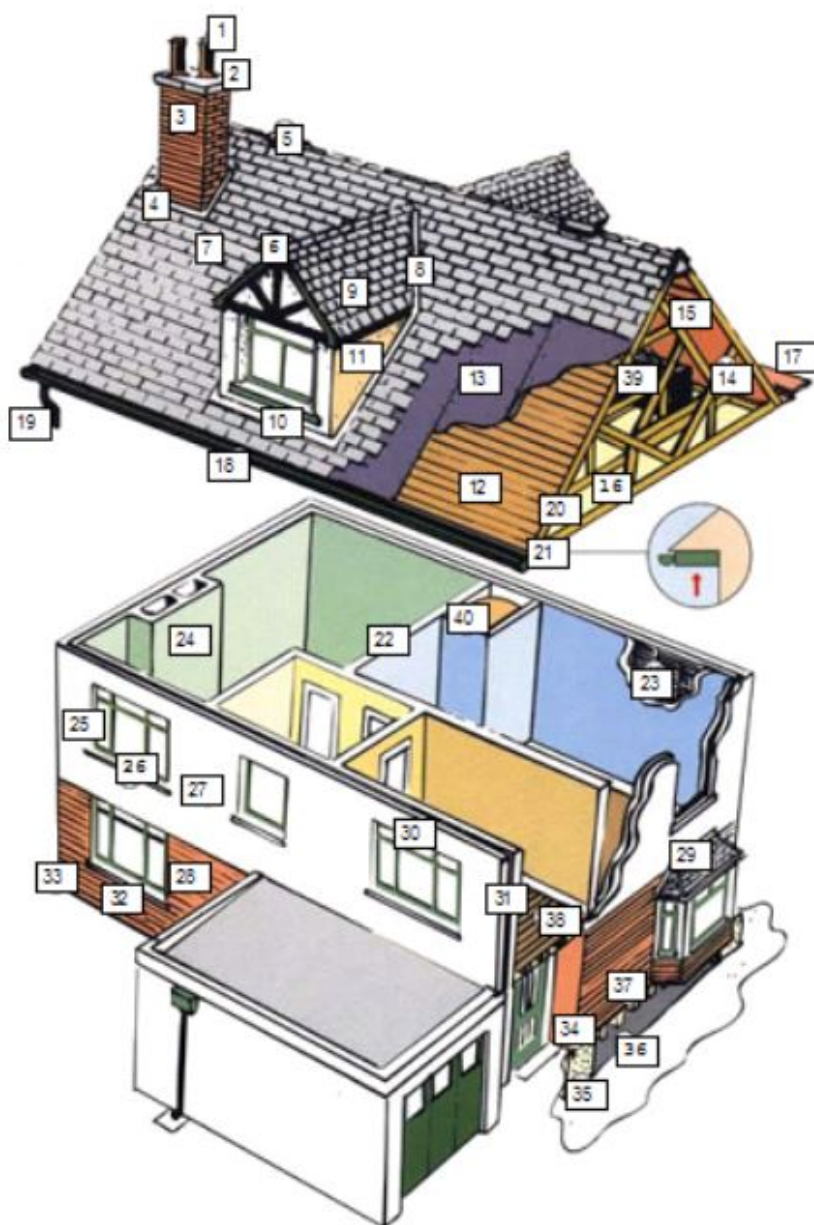
Heating and Hot Water	<p>The subjects benefit from a gas-fired combination boiler which is wall-mounted within the kitchen. This serves steel panelled radiators and supplies hot water throughout the property.</p> <p>Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.</p>

Drainage	<p>Drainage is connected to the Local Authority mains sewer.</p> <p>Drainage covers etc were not lifted.</p> <p>Neither drains nor drainage systems were tested.</p>

Fire, Smoke and Burglar Alarms	<p>Visually inspected.</p> <p>No tests whatsoever were carried out to the system or appliances.</p> <p>New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.</p>

Additional limits to Inspection	<p>A restricted inspection was possible only of the roof and chimneys from ground level.</p> <p>The property was vacant, furnished and had floors covered at the time of our inspection. Internal cupboards and wardrobes are stored with contents and therefore, a limited inspection of these areas was possible only.</p> <p>It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.</p> <p>We were unable to gain access to internal elements of the garage due to the inspecting surveyor not being provided with an access key.</p> <p>No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.</p> <p>It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.</p>

Notes	<p>Weathering was noted to the chimney stacks. It should be appreciated that they are of an age where on-going maintenance will be required, particularly to flashing details to ensure water tightness.</p> <p>Damp staining was evident to surrounding timbers of the chimney stack within the roof void and further investigation of the external flashing details is recommended. Repairs may be required.</p>

	Roofing including Roof Space

Notes	<p>The roof was noted to be in fair order commensurate with the age and type of property although some ongoing maintenance and repairs are likely to be required in the normal manner.</p> <p>Concrete tiles are typically guaranteed for 30 years but have a reasonable life expectancy of around 50/60 years according to the BRE. Life expectancy will often depend on weathering and damage from the prevailing weather. A reputable roofing contractor can advise on life expectancy and potential repair/replacement costs.</p> <p>Roof timbers within the roof void area have been removed and altered in the past. We would recommend that an architect or structural engineer should confirm that the current arrangement is adequate.</p> <p>Where accessible and visible, the roof void generally appeared in satisfactory order although we would comment that damp staining was evident to the structural timbers surrounding the chimney stack and therefore, further investigation is therefore recommended.</p>

Notes	<p>There is evidence of corrosion to sections of the cast iron fittings which could lead to leakage. Ongoing maintenance and repairs should be envisaged.</p>

4. Valuation and Conveyance Issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

Matters for a Solicitor or Licensed Conveyancer

You should clarify from your legal advisor the extent of common repair liability.

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include the conversion of the attic space to form amenity space. We cannot confirm the age of the alterations carried out. On the balance of probability the alterations are likely to have been carried out in excess of 20 years ago.

The property is located within a mining area where past underground mineral workings have been undertaken. We would therefore recommend that a mining report be obtained from the Coal Authority to ascertain the proximity of such mine working.

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

We assume that the carriageways etc., ex adverso the subjects are the responsibility of the Local Authority. It is also assumed that any new access roads, footpaths etc., will be private and will be brought up to adoption standards and liability thereafter will be shared according to use.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

The neighbouring property appears to benefit from a right of way over the subject plot. Your legal conveyancer should confirm the arrangements are adequate via reference to the Title Deeds.

Estimated Reinstatement Cost for Insurance Purposes**£285,000**

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £285,000.



TERMS AND CONDITIONS OF SINGLE SURVEY

GENERAL

1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

DESCRIPTION OF THE REPORT

2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, **visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.**

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the Report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Report of Property that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a register of asbestos and effective management plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:

2.3.1 Category 3:

Urgent repairs or replacement are needed now. Failure to deal with them may cause problems to other parts of the Property or cause a safety hazard. Estimates for repairs or replacement are needed now.

2.3.2 Category 2:

Repairs or replacement requiring future attention, but estimates are still advised.

2.3.3 Category 1:

No immediate action or repair is needed.

WARNING:

If left unattended, even for a relatively short period, Category 2 repairs can rapidly develop into more serious Category 3 repairs. 2.6 Energy Report

A section is included that makes provision for an Energy Report, relative to the Property. The Surveyor will collect physical data from the Property and provide such data in a format required by an accredited energy company. The Surveyor cannot of course accept liability for any advice given by the energy company.

2.7 Valuation & Conveyancer Issues

The last section of the Report contains matters considered relevant to the conveyancer (solicitor). It also contains the Surveyor's opinion both of the market value of the Property and of the re-instatement cost, as defined below.

"Market Value" is the estimated amount for which a property should exchange on the date of valuation within a willing buyer and willing seller in an arms-length transaction after proper marketing wherein the parties have each acted knowledgeably, prudently and without compulsion. The valuation figure is reflective of the overall condition as apparent at the time of our inspection.

The property under report comprises a two-storey end terraced dwellinghouse, constructed on behalf of the Local Authority originally for letting purposes. The property under report is located within an established residential area of an ex-local authority nature to the Chryston district of Glasgow. Surrounding properties are of a similar age and style, with local amenities and public transportation found within short distance.

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include the conversion of the attic space to form amenity space. We cannot confirm the age of the alterations carried out. On the balance of probability the alterations are likely to have been carried out in excess of 20 years ago.

The property is located within a mining area where past underground mineral workings have been undertaken. We would therefore recommend that a mining report be obtained from the Coal Authority to ascertain the proximity of such mine working.



The energy efficiency rating of your home

1 Cavity wall insulation

Cavity wall insulation, to fill the gap between the inner and outer layers of external walls with an insulating material, reduces heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. The insulation material is pumped into the gap through small holes that are drilled into the outer walls, and the holes are made good afterwards. As specialist machinery is used to fill the cavity, a professional installation company should carry out this work, and they should carry out a thorough survey before commencing work to ensure that this type of insulation is suitable for this home and its exposure. They should also provide a guarantee for the work and handle any building standards issues. Further information about cavity wall insulation and details of local installers can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk).

2 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

3 Heating controls (room thermostat)

The heating system should have a room thermostat to enable the boiler to switch off when no heat is required. A competent heating engineer should be asked to do this work. Insist that the thermostat switches off the boiler as well as the pump and that the thermostatic radiator valve is removed from any radiator in the same room as the thermostat. Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

4 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent).
