The accommodation briefly comprises entrance hall, lounge, conservatory, kitchen, two bedrooms, bathroom, gardens to front and rear and a single garage.**

Stairs to first floor landing, double radiator, telephone point, doors to.

Gas fire with marble fascia and hearth and wooden surround, brick facia wall, T.V. point, two double radiators, patio doors to.

**Conservatory**

9' 2" x 7' 3" (2.79m x 2.21m)

Of uPVC construction, power and light, wood effect laminate floor, French doors to rear garden.

**Kitchen**

10' 3" x 5' 7" (3.12m x 1.7m) (This measurement includes the area occupied by the kitchen units)

Comprising stainless steel single drainer sink unit with cupboards under, base and eye level units providing work surfaces, built in electric oven and gas hob with extractor fan over, integrated dishwasher, plumbing for washing machine, space for fridge/freezer, tiled splash backs, wall mounted gas fired boiler serving domestic hot water and central heating (in need of replacing), window to front aspect.

Refitted white suite comprising panelled bath, with mixer shower attachment, low flush W.C., pedestal hand wash basin, part tiled walls, tiled floor, extractor fan, radiator.

Rear - Low maintenance, southerly facing garden, patio area, brick retaining wall, gravel, steps leading up to gated pedestrian access to rear, enclosed by wooden fencing and brick wall.

Garage - Situated at the rear of the property, parking space in front. We understand the garage is a leasehold with a lease of 999 years granted in 1995 and a peppercorn rent.

Front - Low maintenance, gravel, picket fence.
