Offered with no chain is this three bedroom bay fronted end of terrace which is situated within walking distance of the town centre and benefits from uPVC double glazing, a refitted kitchen with built in appliances and gas radiator central heating. The property further offers a cellar and three double bedrooms. The accommodation briefly comprises entrance hall, dining room, lounge, kitchen, bathroom, cellar, three bedrooms and a rear garden.
