### DESCRIPTION

A block of arable land extending in total to **8.14 acres (3.29 hectares)** (more or less) fronting Harpers Drove, Ramsey Heights, Ramsey, Huntingdon. The land is numbered TL2485 - 7621 on the Rural Payments Agency System and is registered under Title Number CB495620 with Land Registry. The field is accessed from Harpers Drove.
