


Malthouse Close, Irthlingborough

Offered with no upward chain and situated in a popular cul-de-sac is this immaculately presented modern three bedroomed mid-terraced property with benefits to include gas radiator central heating, uPVC double glazing, re-fitted kitchen with built in appliances, re-fitted shower room, re-fitted cloakroom, off road parking for one car and a single garage. The accommodation briefly comprises entrance hall, cloakroom, lounge/dining room, kitchen, three bedrooms, shower room, front and rear gardens, single garage and off road parking.
