Excellent transport links are nearby, with Little Sutton train station providing easy access to both Liverpool and Chester.

The property offers a great opportunity for buyers looking to personalise a home to their own taste. The entrance hall has a double built in wall cupboard to the right for coats etc., which leads to the bedrooms, bathroom and lounge. The lounge features a gas fire with a marble surround, a single panel radiator, fitted carpet, and a UPVC double glazed patio door opens onto the side garden. The dining room has fitted carpet. The kitchen is fitted with a range of wooden wall, base and drawer units with space for additional appliances.

There are two bedrooms, both benefiting from fitted wardrobes, fitted carpets and radiators. The fully tiled bathroom comprises a corner shower cubicle, a pedestal wash hand basin, WC, Worcester boiler, and access to the loft which is insulated.

Externally, the property benefits from gardens to the side and rear, and a driveway to the front offering off-road parking and access to the detached garage.


