


# Description

Janson Close is a one bedroom back-to-back end terrace property situated on the popular Bower Manor development benefitting from two allocated car parking spaces and a southerly facing rear garden.

## THE PROPERTY:

The accommodation comprises a living/dining room and a kitchen which has a range of wall and base units. The vendor has elected to leave the washing machine, cooker and fridge/freezer as part of the sale. The living/dining room opens to the rear garden.

To the first floor is a good size bedroom and a family bathroom.

Outside – Directly in front of the property is one parking space and across the road is another allocated parking space. To the rear the south facing garden is predominantly laid to lawn and has side access. A large shed has power connected making it an ideal workshop.

## LOCATION:

The property is situated on the east side of Bridgwater with shop close to hand for day to day needs. Allowing good access to junction 23 of the M5 motorway without passing through the town itself. Main line links via Bridgwater Railway station are readily available. There is also a daily coach service to London Hammersmith from Bridgwater Bus Station.
