Situated just off Hatton Park Road is this three storey, three bedroom mews style property which sits behind private electric gates in a courtyard of five properties. The property benefits from uPVC double glazing, gas radiator central heating and built in kitchen appliances and further offers three double bedrooms all with ensuites, three parking spaces and a southerly facing garden. The size of the accommodation should be noted and briefly comprises entrance hall, cloakroom, lounge, kitchen/dining room, utility room, master bedroom with ensuite shower room, second bedroom with ensuite bathroom, third bedroom with ensuite bathroom, gardens and allocated parking.

Comprising single bowl single drainer sink unit with cupboards under, mixer tap, range of base units providing work surfaces, built in electric oven, six ring gas hob and extractor hood over, integrated fridge/freezer and dishwasher, tiled splash areas, tiled floor, window to rear aspect, radiator, inset ceiling lights.

Bedroom Two

17' 2" x 11' 5" narrowing to 8' 8" (5.23m x 3.48m)

Three skylight windows, radiator, part coving to ceiling, part vaulted ceiling, door to.

Ensuite Bathroom

White suite comprising panelled bath with shower fitted over, pedestal hand wash basin, low flush W.C., tiled splash areas, electric shaver point, electric extractor vent, radiator, inset ceiling lights, wood effect floor, obscure window to rear aspect.

Second Floor Landing

Built in storage cupboard, door to.

Ensuite Bathroom

White suite comprising panelled bath with mixer shower attachment, pedestal hand wash basin, low flush W.C., tiled splash area, radiator, electric extractor vent, wood effect floor.

Bedroom Three

12' 6" x 13' 1" (3.81m x 3.99m)

This room has sloping ceilings so some head height is restricted. Two skylight windows, radiator.

Outside

Garden - Mainly laid to lawn, gravel, light, tool shed, wooden fence, gated access to.

Parking - Three spaces, access to courtyard via private electric gates serving five properties.
