GENERAL DESCRIPTION

A unique opportunity to rent a purpose built, detached commercial property in the centre of Eccleshall. The unit has for over 20 years and continues to trade as a ladies hair salon and would ideally suit another hair or beauty based business or a retail/office-based business. The building briefly comprises an open plan cutting and backwash area plus store, bathroom and kitchenette at the rear and is located along a pedestrianised walkway between the High Street and a housing estate on Perle Brook. Internally the property benefits from a Karndean floor covering, double glazed uPVC windows and electric wall heaters. The fixtures and fittings can be left, by way of separate agreement.

LOCATION

The property is located on a path whose entrance is between Eccleshall Fire Station and Will & Jo's Shoe Shop. The unit is around 100m from the central roundabout in the middle of the village and is surrounded by multiple independent boutique style eateries, shops and public houses.

SERVICES

Mains electric, water and drainage are connected. No services have been tested by the agents.

VAT

The rent is not subject to VAT.

Available by way of a new Full Repairing and Insuring lease by way of service charge for a term of years to be agreed and with rent reviews every 3 years and with the incoming tenant paying £250 plus VAT for the preparation of the lease.

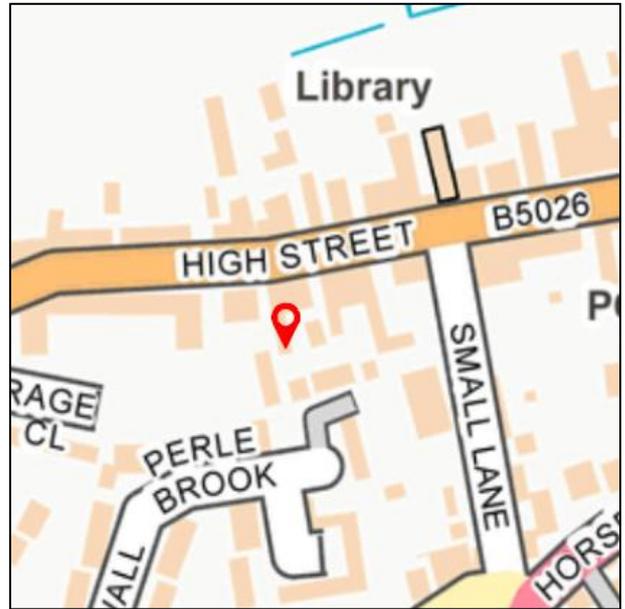
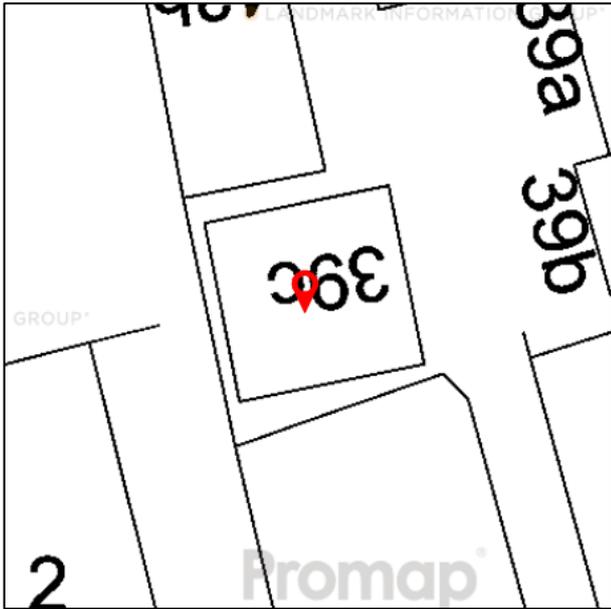
