To the front of the property, a tarmac driveway provides off-road parking for 2 cars. To the rear, the low-maintenance garden is fully enclosed by timber fencing & is mainly laid to paving.

This property is currently under shared ownership in conjunction with Amplus Living Housing Association who have criteria for any purchase. The advertised price is for the sellers 45% share.

£263.88 per month is paid to the Housing Association as rent for the retained share. Management Charge is £25.95 per month & Buildings Insurance is £7.95 per month. Please contact Amplus Living Housing Association for guidance on purchase requirements.

In addition, Amplus Living Housing Association have advised that they would be prepared to staircase a transaction to 100% Freehold ownership. This would mean that any potential purchaser would buy the vendor's 45% share and the remaining 55% share from Amplus Living Housing Association providing a Freehold purchase on completion.


Your conveyancer will advise with regard to the timescales involved and you should satisfy yourself in regard to lending affordability.

Please note that the successful purchaser will be required to pay a £250 reservation fee which will be deducted from the final purchase price.


