Oakfield hall is one of four homes created from the former country home.


Oakfield hall is one of three properties/wings of the main house. Oakfield hall is the one that occupies the large reception and garden of the original house.

This family home is ideal for growing families. The lower ground floor offers fantastic 5th bedroom / study or games room.



The gardens are open to the south and westerly aspects making them ideal for all day use.







Basement
