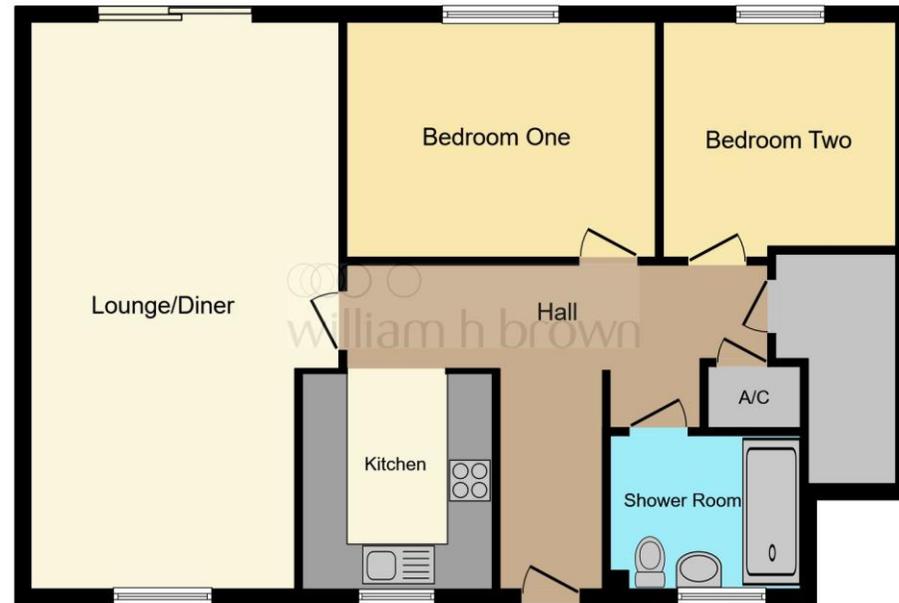
Wantz Haven is an over 60's retirement development in the heart of Maldon, and enjoys a full time warden, communal lounge and laundry area, with regular social events held for residents.
