ACCOMMODATION

A communal lobby opens into the communal entrance hall with stairs rising up to the first floor landing and the entrance door to Flat 2. The entrance hall (18' x 6') has exposed floorboards and space for a study area. The kitchen/breakfast room (14'3" x 9'9") has a vinyl floor, wooden fitted units incorporating a stainless steel sink/drain, a freestanding Zenith electric cooker, a store cupboard with shelving, a walk-in larder with shelving, and a fire exit. The spacious living room (18'2" x 18' max) has exposed floorboards, a tiled open fireplace (not in use) and enjoys a wonderful view out of three sash windows across the Teme Valley. An inner hall leads to the double bedroom (17'5" x 10'10") with feature fireplace (not in use), and to the bathroom (10'1" x 9'7" max) with a vinyl floor, bath with a mixer shower attachment, a hand basin, wc, and an airing cupboard housing the Worcester combi boiler and shelving.

OUTSIDE

The property has two allocated parking spaces and an additional parking space in a shared garage. Visitor parking is also available. The property does not have an enclosed private garden, however there is space for a small table and chairs next to the entrance, two flower beds and a store shed (9'8" x 4'11").

LPG fired central heating – Worcester combi boiler.
