This well-presented upper-floor one-bedroom flat on Windrush Drive offers modern, low-maintenance living in a popular residential area of High Wycombe. The property features an inviting open-plan kitchen and reception room, creating a bright and sociable living space that opens out onto a private balcony, ideal for relaxing or enjoying the surrounding views. It further benefits from a 172-year lease, providing excellent long-term security, along with an allocated parking space for added convenience.

High Wycombe town centre and mainline train station are approx. 1.04 miles from the property. With schools and bus route nearby.

This home is offered for sale via the Modern Method of Sale (T&Cs apply), making it an appealing opportunity for both first-time buyers and investors.


