







Description

Larch Close is a well presented two bedroom mid terrace property situated on the popular Bower Manor development benefitting from two allocated parking spaces.

THE PROPERTY:

The accommodation comprises an entrance hall with stairs to the first floor, a sitting room which leads to a kitchen/dining room with a range of base and wall units along with spaces for appliances, along with a patio door to the rear garden.

To the first floor is a double and a single bedroom along with a shower room.

Outside – To the front of the property there is a lawned garden with a path leading to the front door. The garden to the rear has been designed with low maintenance in mind with a patio area and a shingled garden. There is a gate at the end of the garden which gives access to the tandem allocated car parking spaces to this property.

LOCATION:

The property is situated on the east side of Bridgwater with good access to junction 23 of the M5 motorway without passing through the town. The Bower Manor development offers shops for day to day needs and there is a regular bus service to the town centre. Bridgwater College, offering higher education, is close by. The recently built Bridgwater Hospital is located a short walk away. The property is situated approximately 1.5 miles from the town centre that offers an excellent range of facilities including retail, educational and leisure amenities. Main line links are available via Bridgwater Railway Station. Bridgwater offers a daily coach service to London together with a regular bus service to Taunton, Weston-super-Mare and Burnham-on-Sea.
