SITUATION: Tudor Cottage is situated in the centre of Maresfield within a short walk of the village stores, inn, church and primary school. The nearest main town is Uckfield with comprehensive shopping facilities, cinema, leisure centre/swimming pool complex, restaurants and railway station with services to London Bridge and East Croydon. KITCHEN: with range of pine fronted cupboard and drawer units with work surfaces over, inset one and a half bowl stainless steel sink unit with mixer tap, range of matching wall cupboards, space and plumbing for washing machine and dishwasher, gas fired Rayburn (in need of repair or replacement), tiled floor, part tiled walls, stable door to the garden, beamed ceiling and windows to the rear and side, exposed sandstone wall.
