Shipston on Stour is a former market town situated in South Warwickshire. The town is a busy local centre with good shopping, schooling and recreational facilities serving its own population and several surrounding villages. The larger centres of Stratford-upon-Avon, Banbury and Oxford are accessible. Junctions 11 and 15 of the M40 Motorway are accessible at Banbury and Warwick respectively. There are main line stations at Moreton in Marsh and Banbury with train services south to Oxford and London respectively.

Second Floor Flat, London House is a spacious apartment forming part of a period property in a prime position in the town centre. Accessed by a communal front door from the High Street, the property is located on the second floor accessed by a staircase. From the living room, glazed double doors open to a small roof terrace.

Entrance Hall with doors leading to the rooms, a window to the side of property. **Living Room** 16' x 17' (4.88m x 5.18m) with glazed double doors leading on to roof terrace at the rear of the property and window to the front with outlook onto the High Street. **Store Room/Office** 6'4" x 7'8" (1.92m x 2.34m) with Velux window to roof. **Kitchen/Dining Room** 12'6" x 13'10" (3.82m x 4.22m) with fitted kitchen units, Belfast sink, fridge, freezer, washing machine, dishwasher, electric hob and single electric oven. Window to the side of the property. **Bedroom One** 14'4" x 13'1" (4.36m x 3.99m) with outlook to the front of the property over the High Street. **Bathroom** with panelled bath, wash hand basin, WC, extractor fan and window to side. **Bedroom Two** 10'11" x 11'1" (3.34m x 3.39m) with outlook to the side of the property. **Ensuite Shower Room** with shower cubicle, WC and hand wash basin and window to side.

There is a private roof terrace with staircase leading down and shared rear yard and alleyway returning to the High Street.
