Regency Park consists of 6 homes each set on 0.5 acres on a total of 3 acres. The development boasts modern conveniences in an ideal location with socio-economic activities in close proximity.

Each house is set on 2 floors designed to have large airy spaces and uninterrupted movement from one room to the other.

The ground floor features a sunken spacious lounge with a fireplace and a double volume ceiling. The lounge has large windows which allow natural light to fill the room.
