A beautifully positioned stone built detached bungalow located in the idyllic hamlet of Ingoe dose to the popular village Matfen. The property comprises of entrance hall leading to the kitchen diner with wall and base units, integrated double oven, ceramic hob with extractor fan, space for fridge freezer and plumbing for a washing machine. The large living room is light and spacious and has a stone fire place with open fire leading through an arch to a second reception room.
