LOCATION

Broadgate House is an attractive, modern, office building in a town centre location in the market town of Spalding. Spalding has a population of approximately 31,500 people. It lies adjacent to the A16 providing road communications to Peterborough – 20 miles to the south, Boston 14 miles to the north, and via the A17, Kings Lynn 23 miles to the east, with connections to the A1 at Peterborough, Stamford and Colsterworth. Spalding offers good educational and shopping facilities, together with the Springfields Outlet Shopping Centre. Spalding is considered the capital of the fresh food industry and has a thriving commercial / industrial area just to the north of the town.

DESCRIPTION

Broadgate House comprises a prominently positioned, modern, two storey, steel framed, brick clad office building fronting Westlode Street. Current tenants in Broadgate House include, Nacro, Walker & Quinn Accounting Ltd, Tonic Health and Freeworld Foods Ltd. The property lies adjacent to the Westlode Street Car Park. The entrance to the office suite is via the passageway (to the left of Unit 1 - Nacro) off Westlode Street.

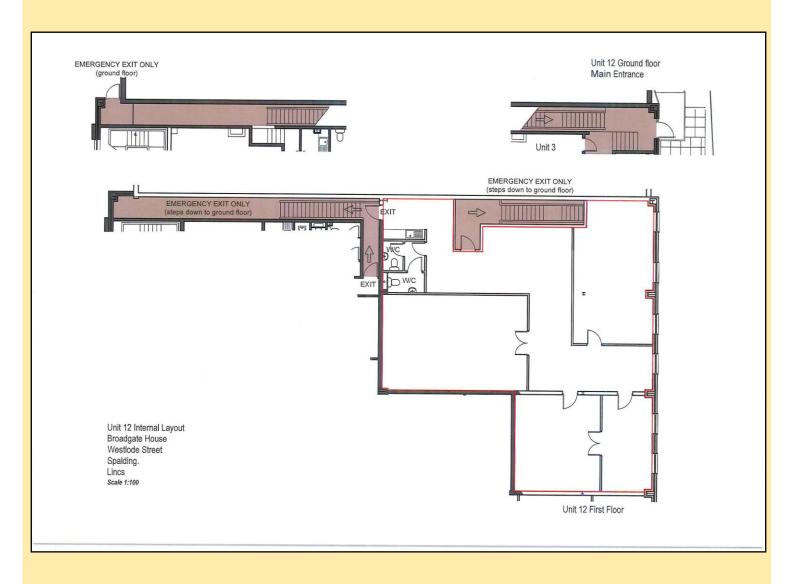

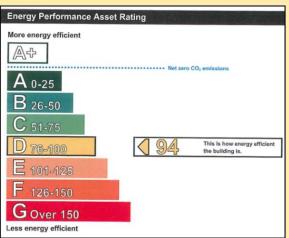
