



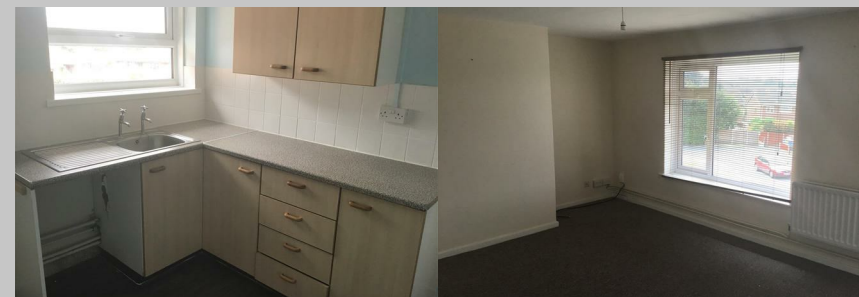

Floor plan

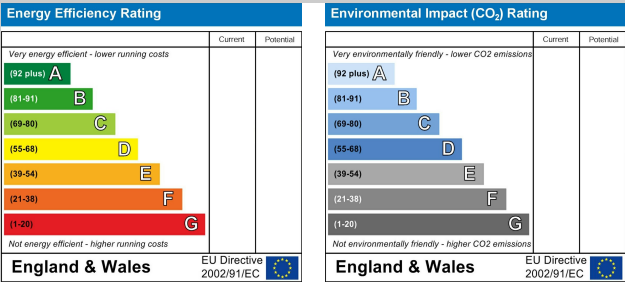
