Upvc double glazed window to side aspect, upvc double glazed French doors leading out into the rear garden, under stairs storage cupboard and radiator.

Kitchen 6'1 x 9'6 (1.85m x 2.90m)

Fitted kitchen comprising wall and base units with work top over, stainless steel one and a half bowl sink / drainer with mixer tap, stainless steel oven, hob and extractor above, built in fridge / freezer, built in washing machine, spot lights, tiled effect floor and upvc double glazed window to front aspect.

Loft access and doors to all rooms.

Upvc double glazed window to rear aspect and radiator.

Bedroom 8'7 max x 13'1 max (2.62m max x 3.99m max)

Upvc double glazed window to front aspect, fitted storage cupboard with shelving and radiator.

Bathroom

White three piece suite comprising panel bath with shower over and shower screen, low level WC, pedestal wash hand basin, part tiled walls, upvc double glazed window to side aspect and radiator.

Front Garden

Garden with shrubs and pathway leading to the entrance door.

Rear Garden

Mainly laid to lawn and fully enclosed by fencing and wall with rear and side access gates, shrub borders, patio area and pathway leading to a timber shed.




