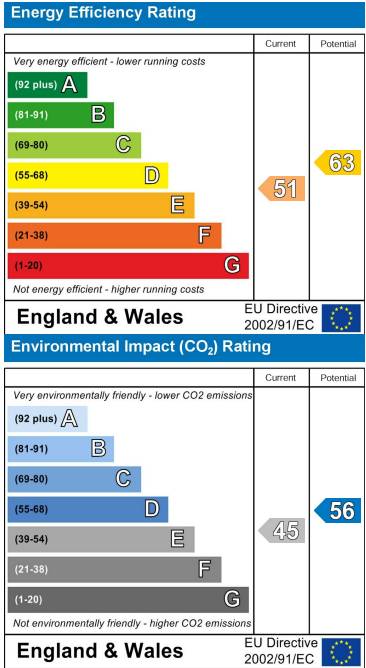


Floor Plan
