LOCATION

The resort town of Clacton On Sea is located 15 miles south east of Colchester, 40 miles east of Chelmsford and 76 miles north east of London, with mainline railway links to London Liverpool Street Station with a journey time of approximately 1.5 hours. The subject premises occupies a prominent trading location on the eastern end of Rosemary Avenue. DESCRIPTION

The property is arranged over ground floor extending to a gross internal area of 1,156 sq ft. The shop benefits from frontage on to Central Parade of 4.7m and a gross depth of 22.86m.
