

Shaftesbury Avenue runs from Seven Dials through to Picadilly Circus where creates a border between Chinatown and Soho. Several bus routes run along Shaftesbury Avenue itself, but this studio apartment also has Tottenham Court Road (Central, Northern and Queen Elizabeth lines) and Covent Garden (Piccadilly line) within a short walk.


