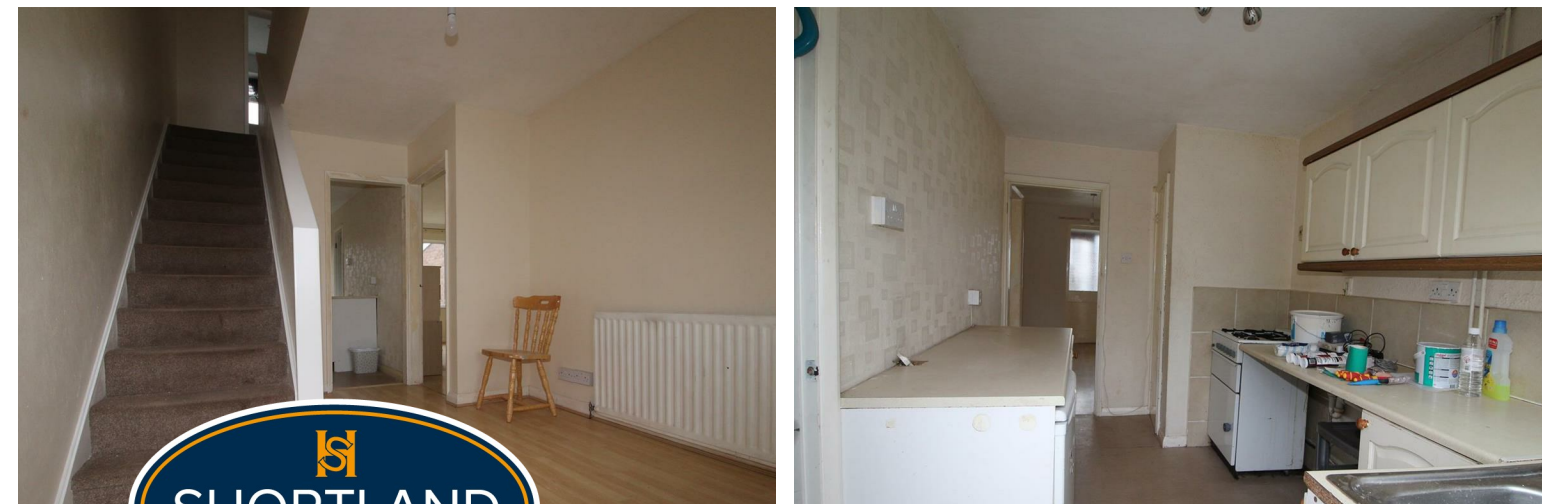
Appliances
