




















Location

Halesowen lies approximately 7 miles from Birmingham City Centre and is just minutes away from junction 3 of the M5 motorway giving access to the greater motorway network all around the West Midlands. The History of Halesowen stems back as far as the Anglo Saxons and it was listed in the Domesday Book as being larger than Birmingham. It forms part of the southern edge of the Black Country and during the industrial revolution it became synonymous with nail and screw making, an industry that still survives to a lesser extent today. Despite its proximity to the Black Country it still retains areas of beauty and Grade I listed Leasowes Park is thought to be one of the first natural landscape gardens in England. In certain areas the town is predominated by a vast array of Victorian houses but further development during the 1960's and 70's saw the building of several large housing estates. It has a number of highly sought after primary and secondary schools. Whilst Halesowen no longer has a train station of its own the Worcester to Birmingham line passes along the northern edge of its boundary and the stations of Cradley Heath, Old Hill and Rowley Regis are all within a few miles of the town centre. Halesowen bus station is a busy interchange and regular service runs to Birmingham City Centre.







Approach

Via tarmac parking area leading to garage, communal areas comprising garden areas to the rear, stairs rising to accommodation giving access into:

Entrance hall

Central heating radiator, access to loft space and intercom

Lounge 11'1" x 16'8" (3.4 x 5.1)

Double glazed window to front with far reaching views, central heating radiator.

Kitchen 11'9" x 7'2" (3.6 x 2.2)

With double glazed window to front, central heating radiator, range of wall and base units with work surface over incorporating sink with mixer tap, gas hob with extractor hood over, oven, washing machine and fridge being integrated.

Bedroom one 10'5" x 12'9" (3.2 x 3.9)

Central heating radiator, double glazed window to rear.

Bedroom two 9'10" x 7'10" (3.0 x 2.4)

With double glazed window to rear, central heating radiator, built in wardrobes.

Bathroom

Tiled flooring, splashbacks, wash hand basin with mixer tap over, bath with mixer tap, double glazed window to side, low level w.c., shower enclosure with shower over, heated towel rail and extractor fan.
