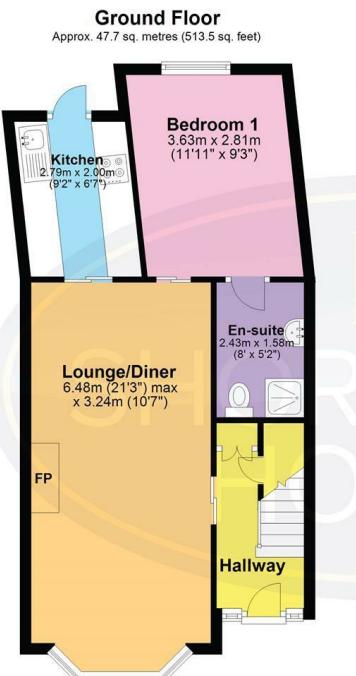


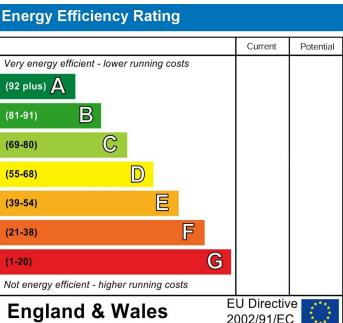
## Floor Plan

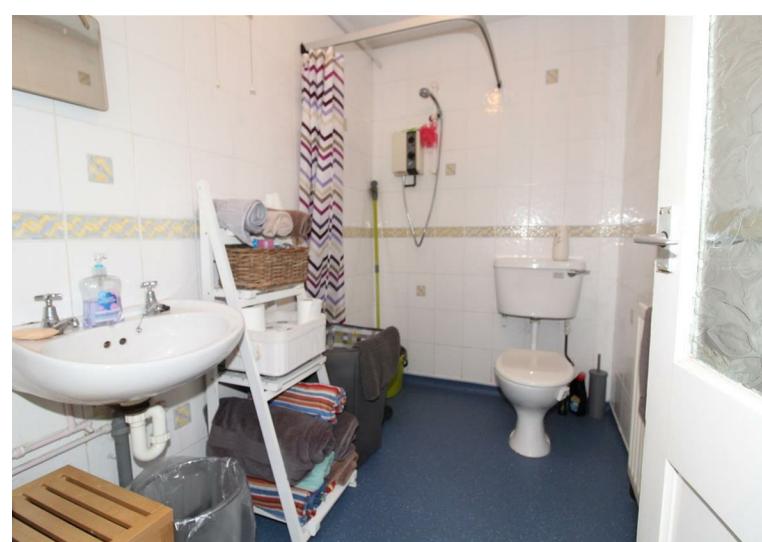
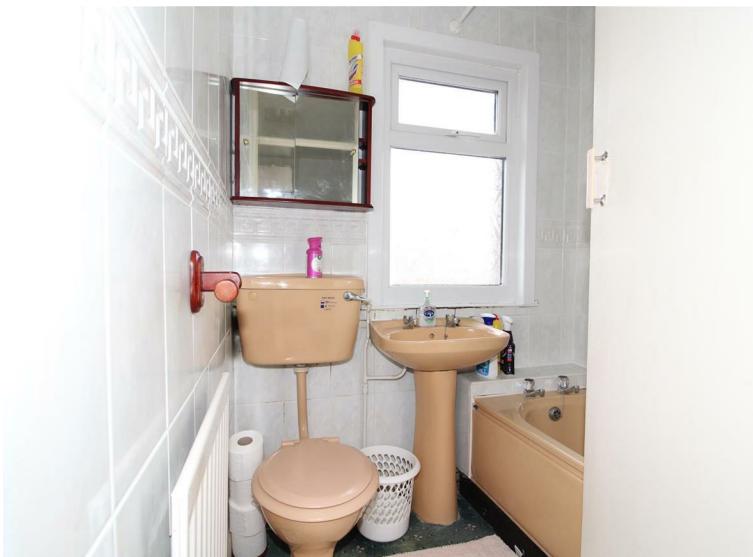
