Situation & Amenities

Bishop Auckland 15 miles, Darlington 17 miles, Durham 25 miles, Newcastle upon Tyne 42 miles, A1(M) 17 miles. Please note all distances are approximate. Situated in the historic market town of Barnard Castle, this property provides easy access to the amenities within the town and its surrounding area. There are a number of nurseries, primary and secondary schools in Barnard Castle including Barnard Castle School and Teesdale School. Darlington and Bishop Auckland are both within close proximity, while the cities of Newcastle, Durham, York and Leeds also easily accessible.

Description

5 Summerlea is a two bedroom ground floor apartment which is closely placed to the town centre of the historic market town of Barnard Castle. Accommodation briefly comprises: Communal entrance. Hallway. Kitchen including fitted wall and base units, contoured work surface, tiles to splashbacks, integral fridge/freezer, integral washing machine, integral oven, integral gas hob, integral extractor hood and a stainless steel sink with mixer tap and draining board. Living room. Two bedrooms. Bathroom including a panelled bath with Mira shower over, WC and hand wash basin. Externally, there is one parking space.

Terms & Conditions

The property shall be let unfurnished by way of an Assured Shorthold Tenancy for an initial term of 6 or 12 months at a rental figure of £475 per calendar month, payable in advance by standing order. In addition, a deposit of £545 shall also be payable prior to occupation.

Referencing

The Landlord's agent will take up references through a

referencing agency. The obtaining of such references is not a guarantee of acceptance.

Holding Deposit

Before your application can be fully considered, you will need to pay to us a holding deposit equivalent to one weeks' rent for the property you are interested in. Once we have your holding deposit, the necessary paperwork should be completed within 15 days or such longer period as might be agreed. Should you be offered, and you accept a tenancy with our Landlord, then your holding deposit will be credited to the first months' rent due under that tenancy. Where, for whatever reason, your holding deposit is neither refunded nor credited against any rental liability, you will be provided with written reasons for your holding deposit not being repaid within 7 days.
