Location

Halesowen lies approximately 7 miles from Birmingham City Centre and is just minutes away from junction 3 of the M5 motorway giving access to the greater motorway network all around the West Midlands. The History of Halesowen stems back as far as the Anglo Saxons and it was listed in the Domesday Book as being larger than Birmingham. It forms part of the southern edge of the Black Country and during the industrial revolution it became synonymous with nail and screw making, an industry that still survives to a lesser extent today. Despite its proximity to the Black Country it still retains areas of beauty and Grade I listed Leasowes Park is thought to be one of the first natural landscape gardens in England. In certain areas the town is predominated by a vast array of Victorian houses but further development during the 1960's and 70's saw the building of several large housing estates. It has a number of highly sought after primary and secondary schools. Whilst Halesowen no longer has a train station of its own the Worcester to Birmingham line passes along the northern edge of its boundary and the stations of Cradley Heath, Old Hill and Rowley Regis are all within a few miles of the town centre. Halesowen bus station is a busy interchange and regular service runs to Birmingham City Centre.

Approach

Via block paved driveway offering parking for a number of cars with bedding to side housing a variety of plants and shrubs leading to access to garage.

Garage

With wooden double doors to front.

Porch

With tiled flooring, double glazed doors and windows to front leading to;

Entrance Hall

With central heating radiator, door to front and stairs rising to first floor accommodation.









Lounge Diner 10'9"(max)9'10"(min)x24'7" (3.3(max)3.0(min)x7.5)

With double glazed windows to front, double glazed door to rear, central heating radiator.

Extended Kitchen 9'6"(min)18'8"(max)x14'9"(max)5'6" (min) (2.9(min)5.7(max)x4.5(max)1.7(min))

With double glazed window to rear and side, double glazed door to side, a range of wall and base units with work surface over incorporating sink with mixer tap, extractor hood, cupboard off, tiling to splashbacks, velux skylights, central heating radiator, space and plumbing for washing machine.

Downstairs W.C.

Low level flush w.c., tiling to splash backs, double glazed window to rear, extractor fan and wash hand basin.

First Floor Landing

With double glazed window to side, access to loft space and doors radiating off to;

Bedroom One 10'9" x 13'1" (3.3 x 4.0)

With double glazed window to front and central heating radiator.

Bedroom Two 10'5" x 10'9" (3.2 x 3.3)

With double glazed window to rear and central heating radiator.

Bedroom Three 7'2" x 7'6"(min)10'2"(max) (2.2 x 2.3(min)3.1(max))

With double glazed window to front, central heating radiator and built in cupboard.

House Bathroom

With shower enclosure having electric shower over, low level flush w.c., feature bath with mixer tap over, wash hand basin with mixer tap, central heating radiator, double glazed window to rear and tiling to splashbacks.

Rear Garden

With slabbed patio areas and pathways stepping up to lawn, feature pond, various beds with plants and shrubs, timber fencing to enclose.
