This well-planned chalet bungalow is situated in a convenient position set well back from Bramley Crescent on a popular established residential development served by a comprehensive range of shops, library, infant and junior schools. The picturesque village centre of Bearsted is close by where there is a delightful Green framed by historic buildings, sports/leisure clubs, restaurants, parish church and London line station (Victoria one hour). Mote Park, a local beauty spot, is within walking distance where there are excellent recreational facilities and a Park & Ride bus service to Maidstone town centre, which is approximately 3-miles distance.

The property was constructed approximately 55-years ago with a later addition and has just been refurbished, having the benefit of gas fired central heating with a new boiler, replacement UPVC double glazed windows, modern fitted kitchen and bathroom, newly fitted carpets and vinyl floor covering, panelled internal doors and new decoration throughout.

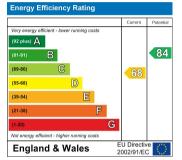

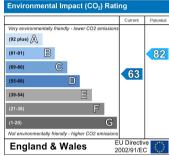
