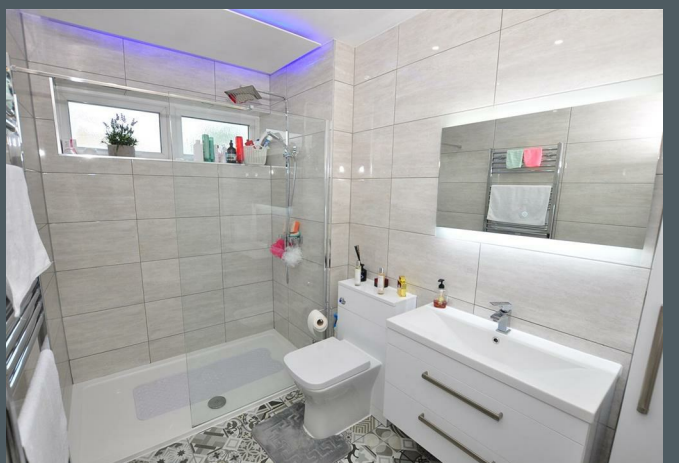

Location

Halesowen lies approximately 7 miles from Birmingham City Centre and is just minutes away from junction 3 of the M5 motorway giving access to the greater motorway network all around the West Midlands. The History of Halesowen stems back as far as the Anglo Saxons and it was listed in the Domesday Book as being larger than Birmingham. It forms part of the southern edge of the Black Country and during the industrial revolution it became synonymous with nail and screw making, an industry that still survives to a lesser extent today. Despite its proximity to the Black Country it still retains areas of beauty and Grade I listed Leasowes Park is thought to be one of the first natural landscape gardens in England. In certain areas the town is predominated by a vast array of Victorian houses but further development during the 1960's and 70's saw the building of several large housing estates. It has a number of highly sought after primary and secondary schools. Whilst Halesowen no longer has a train station of its own the Worcester to Birmingham line passes along the northern edge of its boundary and the stations of Cradley Heath, Old Hill and Rowley Regis are all within a few miles of the town centre. Halesowen bus station is a busy interchange and regular service runs to Birmingham City Centre.

Approach

Via tarmac driveway to front offering parking for a number of cars stepping up to:

Porch

With double glazed window and door to front, cupboard off.

Entrance hall

Cupboard off, central heating radiator, stained glass windows and door to front, stairs to first floor accommodation.







Kitchen diner 15'8" x 9'2" (4.8 x 2.8)

With double glazed window and door to rear, central heating radiator, range of wall and base units with work surfaces over incorporating sink with mixer tap, gas hob with extractor hood over, oven, integrated dishwasher and washing machine, tiling to splashbacks, stairs and cupboard off.

Garage 14'9" x 8'6" (4.5 x 2.6)

With metal up and over door to front, various cupboard units.

First floor landing

With cupboard off, stairs to second floor accommodation.

Lounge 11'9" min 14'5" max x 27'6" (3.6 min 4.4 max x 8.4)

Double glazed window to front offering far reaching views, central heating radiator, electric fire with feature surround.

Bedroom four 9'6" x 9'10" (2.9 x 3.0)

Double glazed window to rear, central heating radiator.

House bathroom

Fully tiled walls and floor, wash hand basin with mixer tap over, low level w.c., shower enclosure with rainfall shower

head over, heated towel rail, extractor fan, mood lighting, electric anti mist smart mirror.

Second floor landing

Access to loft space, doors radiating to:

Bedroom one 9'6" x 12'9" min 15'8" max (2.9 x 3.9 min 4.8 max)

Double glazed window to rear, central heating radiator, built in wardrobe, w.c. off.

W.C.

With low level w.c., wash hand basin with mixer tap over, tiling to splashbacks and cupboard off.

Bedroom two 10'2" x 12'1" (3.1 x 3.7)

Double glazed window to front offering far reaching views, central heating radiator.

Bedroom three 8'6" max 6'6" min x 11'9" (2.6 max 2.0 min x 3.6)

Double glazed window to front offering far reaching views, central heating radiator, built in wardrobes.

Rear garden

Slabbed patio area and pathway, lawn with beds housing various plants and shrubs, further seating area with gravelled border and all with timber fencing and brick walls to enclose.

Tenure
