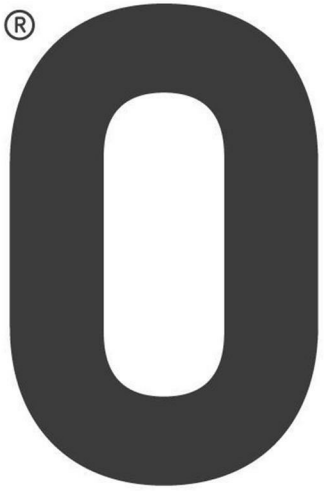

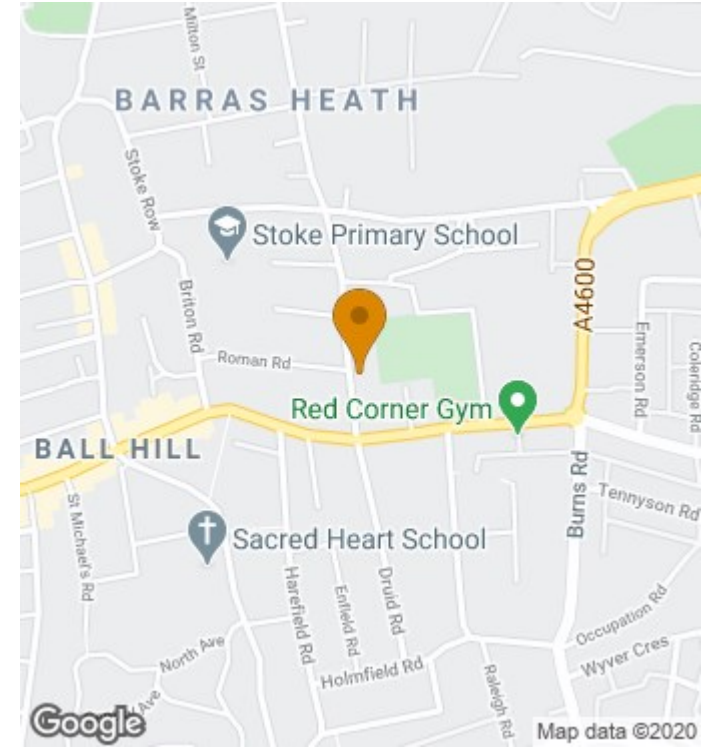


Dimensions

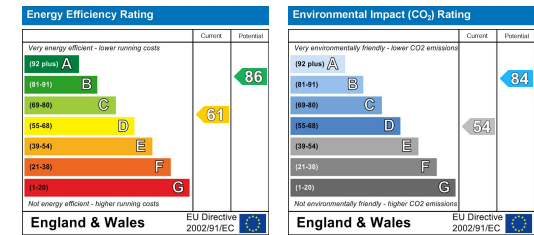
