Location

Halesowen lies approximately 7 miles from Birmingham City Centre and is just minutes away from junction 3 of the M5 motorway giving access to the greater motorway network all around the West Midlands. The History of Halesowen stems back as far as the Anglo Saxons and it was listed in the Domesday Book as being larger than Birmingham. It forms part of the southern edge of the Black Country and during the industrial revolution it became synonymous with nail and screw making, an industry that still survives to a lesser extent today. Despite its proximity to the Black Country it still retains areas of beauty and Grade I listed Leasowes Park is thought to be one of the first natural landscape gardens in England. In certain areas the town is predominated by a vast array of Victorian houses but further development during the 1960's and 70's saw the building of several large housing estates. It has a number of highly sought after primary and secondary schools. Whilst Halesowen no longer has a train station of its own the Worcester to Birmingham line passes along the northern edge of its boundary and the stations of Cradley Heath, Old Hill and Rowley Regis are all within a few miles of the town centre. Halesowen bus station is a busy interchange and regular service runs to Birmingham City Centre.

Via tarmac driveway with lawn area, beds with various plants and shrubs, step up to porch.

Porch

Double glazed window and door to front.

Entrance hall

With central heating radiator with stained glass doors and window to front, cupboard off, stairs rising to first floor accommodation.

Reception room one 11'9" x 15'5" max 10'5" min (3.6 x 4.7 max 3.2 min)

Double glazed bay window to front, gas fire with feature surround.







Reception room two 10'5" x 11'5" (3.2 x 3.5)

Double glazed French doors to rear, central heating radiator.

Kitchen 7'10" x 10'5" max 8'10" min (2.4 x 3.2 max 2.7 min)

Double glazed window to rear, range of wall and base units with work surface over incorporating sink, free standing oven and hob and cupboard off.

Double glazed window to rear, double glazed door to side.

With w.c. and window to side.

Double glazed window to side, cupboard off, access to loft space and doors radiating to:

Central heating radiator, double glazed window to rear.

Bedroom two 10'5" x 10'9" (3.2 x 3.3)

Double glazed window to front, central heating radiator, built in wardrobe.

Bedroom three 7'6" max 5'2" min x 7'6" (2.3 max 1.6 min x 2.3)

Double glazed window to front, range of built in wardrobes.

House bathroom

With double glazed window to rear, suite comprising of bath, wash hand basin, w.c., tiling to splashbacks and central heating radiator.

Rear garden

With slabbed patio area stepping up to lawn, beds with various plants and shrubs and all with timber fencing to enclose.

Garage 17'4" x 8'2" (5.3 x 2.5)

With metal up and over door to front.
