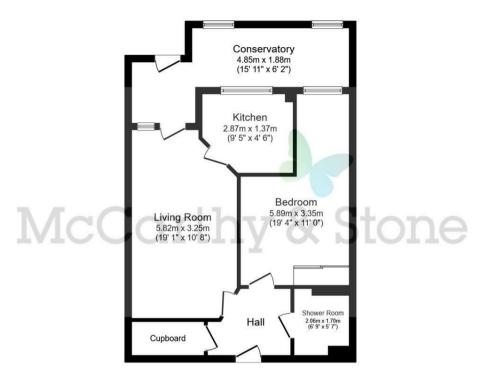












Floor Plan
