### Location

Halesowen lies approximately 7 miles from Birmingham City Centre and is just minutes away from junction 3 of the M5 motorway giving access to the greater motorway network all around the West Midlands. The History of Halesowen stems back as far as the Anglo Saxons and it was listed in the Domesday Book as being larger than Birmingham. It forms part of the southern edge of the Black Country and during the industrial revolution it became synonymous with nail and screw making, an industry that still survives to a lesser extent today. Despite its proximity to the Black Country it still retains areas of beauty and Grade I listed Leasowes Park is thought to be one of the first natural landscape gardens in England. In certain areas the town is predominated by a vast array of Victorian houses but further development during the 1960's and 70's saw the building of several large housing estates. It has a number of highly sought after primary and secondary schools. Whilst Halesowen no longer has a train station of its own the Worcester to Birmingham line passes along the northern edge of its boundary and the stations of Cradley Heath, Old Hill and Rowley Regis are all within a few miles of the town centre. Halesowen bus station is a busy interchange and regular service runs to Birmingham City Centre.

### Approach

Via tarmac driveway with lawned area to side, graveled bedding with various plants and shrubs stepping up to:

### Porch

With double glazed window and door to front, cupboard off.

### Entrance hall

With central heating radiator, stairs to first floor accommodation.

### Dining room 8'6" x 14'5" (2.6 x 4.4)

Double glazed window to front, central heating radiator.













**Kitchen 15'8" x 9'2" (4.8 x 2.8)**

Double glazed window and door to rear, central heating radiator, range of wall and base units with work surface over incorporating sink with mixer tap, gas hob with extractor hood over, double oven, space and plumbing for washing machine, tiling to splashbacks.

**Utility room**

With range of wall and base units with work surface over.

**Lounge 15'8" x 12'1" min 15'1" max (4.8 x 3.7 min 4.6 max)**

With double glazed bay window to front, central heating radiator.

**Bedroom four 10'2" max 6'6" min x 9'2" (3.1 max 2.0 min x 2.8)**

With Double glazed window to rear, central heating radiator, cupboard off.

**House bathroom**

With wash hand basin with mixer tap over, low level w.c., bath with shower over, heated towel rail, tiling to splashbacks.

**Second floor landing**

Access to loft space and doors radiating to:

**Bedroom one 9'10" x 16'0" (3.0 x 4.9)**

Central heating radiator, double glazed window to rear.

**Bedroom two 7'2" x 12'1" (2.2 x 3.7)**

With central heating radiator, double glazed window to rear.

**Bedroom three 8'6" x 12'1" (2.6 x 3.7)**

Central heating radiator, double glazed window to rear, cupboard off.

**Shower room**

With shower enclosure with electric shower over, low level w.c., wash hand basin with mixer tap over.

**Rear garden**

Wooden decked seating area stepping down to lawn, beds with various plants and shrubs and all with timber fencing to enclose.

**Tenure**
